SUBJECT PRESENTATION:

Family Law includes the analysis of three main divisions: the treatment of marriage, which addresses requirements and formalities, the relaxation and dissolution of the marital bond, and the personal and patrimonial relationship between the spouses; the treatment of parentage, which includes its various classes and the parent-child relationship; and analysis of the institutions for the protection of minors and the disabled. Additionally, due to the developments in our society, it has become necessary to include the study of permanent extramarital unions. Moreover, the current system for protection of the most disadvantaged groups in the family context (minors and the disabled) requires special reference to their regulation. Social workers are seen as a fundamental part of the protection framework, meaning indepth knowledge of these concepts is necessary for their subsequent practical application.

- Knowing and understanding the institutions for protection of minors and the disabled, in both national and regional legislation.
- Knowing and understanding the consequences of administrative and/or judicial action to defend minors and the disabled, in both national and regional legislation.
- Knowing and understanding criminal law as it relates to minors; particularly with regard to their protection and prosecution.

CONTENT:

Family and Family Law. Basic family relationships: lineage and maintenance obligation. Family and marriage: Marriage and its effects. Matrimonial crises: separation, dissolution and nullity. Common effects of matrimonial crises. Parentage. Parental authority (*patria potestad*). The new institutions for protection of minors and the disabled: neglect, administrative care and at-risk situations: national and regional legislation. The consequences of public intervention in the protection of minors: fostering and adoption; special reference to international adoption. Criminal laws for the protection of minors. Minors and the criminal law (*Ley Penal del Menor*).
