## SUBJECT PRESENTATION

The subject is intended to develop knowledge of mediation as a cooperative out-of-court system for the management, transformation and resolution of conflicts. It is structured in three main blocks. The first analyses conflicts, their elements and categories, and traditional conflict resolutions systems, before examining so-called ADR (alternative dispute resolution) mechanisms in detail, with particular attention to the distinction between mediation and other similar mechanisms such as negotiation, conciliation or arbitration.

The second block provides a detailed analysis of mediation, its regulatory framework, its concept and fundamental principles. It also considers the mediation process, its legal effects and the techniques to be applied at each stage of the process.

The third block focuses on the study of the different fields in which mediation may be practiced, paying particular attention to mediation as applied to conflicts involving family, education, communities, and intercultural issues.

### **1. COMPETENCIES**

- 1. Knowing and understanding the nature and structure of conflict and the features of the different conflict resolution systems. Identifying and managing complex ethical conflicts, dilemmas and problems, designing strategies to address such issues and reflecting on outcomes.
- 2. Knowing the principles that govern the institution of mediation, as well as the structure of the process and the techniques used therein.
- 3. Assessing the benefits of so-called ADR mechanisms, principally mediation.
- 4. Knowing the various intervention contexts in which mediation is applied: family, school, intercultural issues, and the criminal context for minors and adults.
- 5. Reflecting on the contributions mediation can make for social work professionals as a fundamental resource in community intervention.
- 6. Being able to work in a collaborative fashion with individuals, families, groups, organizations and communities, as well as how to work with their needs and circumstances.
- 7. Assessing potential needs and options for guiding conflict intervention strategies to be presented to the various groups involved.

### 2. CONTENT

Conflict: concept, elements, categories and styles.

Traditional and alternative conflict resolution systems: courts and the various ADR mechanisms.

General theory of mediation: concept, principles, process and effects. Civil mediation: regulatory framework.

Mediation in family contexts: concept, fields, principles, regulatory framework and experiences. Processes and techniques applicable to family mediation.

Mediation in other fields: criminal law for adults and minors, education, community, intercultural issues, workplace.
